



# DE ANZA ASSOCIATED STUDENT BODY FLEA MARKET NEWSLETTER May 2007



**SIX MONTH CONTRACTS:** WE ARE NOW ACCEPTING **NEW CONTRACT REQUESTS** BEGINNING WEDNESDAY, MAY 9 UNTIL FRIDAY, MAY 29 OR UNTIL SOLD OUT. VISIT OUR WEB SITE FOR INSTRUCTIONS AND SIX MONTH CONTRACT FORM.

**FOOD COURT MOVE:** BEGINNING WITH THE JULY 7 FLEA MARKET, THE FOOD COURT WILL RELOCATE TO ROW A (1-16) AND M (48-49), N (1-2). PLEASE REVIEW THE ENCLOSED VENDOR AREA MAP. WE APOLOGIZE FOR ANY INCONVENIENCE THIS MAY CAUSE BUT WE FEEL THIS WILL MAKE A MORE ENJOYABLE ATMOSPHERE FOR FOOD PATRONS AND IS EXPECTED TO REDUCE THE SMOKE AND VEHICLE TRAFFIC IN THE FLEA MARKET DURING PEAK HOURS.

**OFFICE MOVE:** DUE TO CONSTRUCTION AND RENOVATION EFFORTS, OUR OFFICE WILL TEMPORARILY MOVE. THE OFFICE WILL BE CLOSED ON WEDNESDAY, MAY 16 AND THURSDAY, MAY 17. WE WILL MOVE TO THE TEMPORARY LOCATION, (LOT C) UNTIL SEPTEMBER, THEN MOVE BACK TO OUR CURRENT LOCATION. DURING THIS TIME WE WILL BE MONITORING OUR PHONE LINES AND WILL PROCESS APPLICATIONS AS USUAL.

**ALL VENDORS: EACH VEHICLE** ENTERING THE FLEA MARKET **MUST HAVE AN ENTRY TICKET. PLEASE DISPLAY YOUR TICKET AT YOUR BOOTH IN CLEAR VIEW.** WE DO RANDOM TICKET AND ID CHECKS AND IF YOUR TICKET IS CLEARLY POSTED WE USUALLY DO NOT NEED TO INTERRUPT YOUR SALES. IF YOU PARK YOUR VEHICLE ELSEWHERE, KEEP A PHOTOCOPY OF YOUR TICKET ON THE DASHBOARD. FLEA MARKET CONFIRMATION TICKET IS NOT VALID FOR PARKING OUTSIDE YOUR VENDOR SELLING SPACE. PARKING PERMITS ARE REQUIRED AT ALL TIMES BY ALL PATRONS AND VENDORS PARKING OUTSIDE THE VENDING AREAS.

**ALL VENDORS:** VENDORS MAY NOT SELL, SUBLET, SHARE OR GIVE UNNEEDED SPACES TO OTHER VENDORS WITHOUT PRIOR APPROVAL FROM FLEA MARKET STAFF. ANYONE CAUGHT SELLING, GIVING, SHARING OR RECEIVING SPACES WITHOUT PRIOR APPROVAL WILL BE ASKED TO LEAVE WITHOUT A REFUND, AND MAY NOT BE ALLOWED TO PARTICIPATE IN FUTURE FLEA MARKETS. ID WILL BE CHECKED AT ENTRY AND RANDOMLY DURING THE EVENT.

**ALL VENDORS:** ONCE YOUR VEHICLE IS IN YOUR SPACE, BY 7:30 AM, THERE IS TO BE **NO DEPARTING UNTIL AFTER 2:00 PM!** THIS IS ENFORCED RAIN OR SHINE. IF YOU NEED TO LEAVE PRIOR TO 2:00 PM YOU MUST FIRST GET PERMISSION FROM THE INFORMATION BOOTH AND GET A WALKING ESCORT. **THIS IS A SERIOUS SAFETY AND LIABILITY CONCERN! ANYONE LEAVING EARLY WITHOUT AN ESCORT MAY NOT BE ALLOWED TO PARTICIPATE AGAIN IN THE FUTURE.** ALL VENDORS MUST BE OFF CAMPUS BY 6:00 PM, THE CLEANING CREWS START AT THAT TIME. **IF YOU ARE NOT OUT BY 6:00 PM YOU WILL BE FINED FOR LATE DEPARTURE!** FIRST OFFENSE WILL RESULT IN A \$25 FINE, SECOND OFFENSE \$50, THIRD OFFENSE \$100.

**“PACK IT IN, PACK IT OUT!”: GARBAGE, TRASH AND RECYCLE SERVICES ARE NOT PROVIDED.** ALL VENDORS MUST PACK OUT **ALL** THEIR TRASH, GARBAGE, BOXES, UNSOLD ITEMS, ETC. LEAVE YOUR VENDOR SPACE AS CLEAN AS YOU FOUND IT. **FAILURE TO COMPLY MAY RESULT IN FINES AND/OR LOCKOUT.** THERE WILL BE NO WARNINGS OR GRACE PERIOD.

**NO DOGS ALLOWED:** DOGS ARE NOT ALLOWED AT THIS FLEA MARKET UNLESS THEY ARE CLEARLY IDENTIFIED, (VEST), AS A SERVICE DOG AND ARE ACTING IN THE CAPACITY AS A SERVICE DOG..

**RESALE NUMBER/SELLER'S PERMIT:** ALL VENDORS THAT HAVE A RESALE NUMBER MUST SHOW IT UPON REQUEST. PLEASE BE SURE TO BRING IT WITH YOU EVERY TIME.
