FLASH NOTICE !!!

We have just been notified that beginning with the August 1 Flea Market and extending possibly through the September 5 Flea Market, (two months), part of the Flea Market will be fenced off for electrical work.

Row A in Lot B will be fenced off so we needed to temporarily relocate all food vendors and six month contractors currently in Row A to other areas.

In addition, there will be four (4) Flea Market dates that the campus will not have electricity. This means that there will be no lighting in the parking lots and the indoor bathrooms will be closed. The dates that there will be no electricity;

- * **September 5, 2009**
- * **January 2, 2010**
- * **July 3, 2010**
- * **September 4, 2010**

During the above dates, we will have extra portable bathrooms available.

THE NEW REFUND POLICY IS NOW IN EFFECT: The last day to apply for a refund is ten (10) calendar days prior to the market date. The original ticket must be received by the Flea Market office ten days prior to the market date. Refunds shall be for a maximum of 50% of fee for day(s) of refund. There will not be any Credits or Rain Checks. Refunds will be processed and mailed to you within three (3) weeks.

ALL VENDORS: EACH VEHICLE entering the Flea Market **MUST HAVE AN ENTRY TICKET**. Please have your entry ticket and Driver License ready to show upon entry. If you plan to bring in two or more vehicles, call our office for instructions. Ticket purchaser, (name on the ticket), must be present the entire day of the Flea Market. **PLEASE DISPLAY YOUR TICKET at your booth, IN CLEAR VIEW at all times**. If you are not going to leave your vehicle in your assigned space, you must have it unloaded and out of the Flea Market selling areas before 7:30am. Do not park in another vendor stall even if it is empty, expensive parking citations will be issued.

“PACK IT IN, PACK IT OUT!”: GARBAGE, TRASH AND RECYCLE SERVICES ARE NOT PROVIDED. All vendors must pack out ALL their trash, garbage, boxes, unsold items, etc. Trash service for vendors is not provided. Do not use the garbage cans or debris boxes for **ANYTHING!** **FAILURE TO COMPLY MAY RESULT IN FINES AND/OR LOCKOUT**. There will be no warning or grace period. If we cannot reduce the build-up of trash, we will be forced to raise vendor prices.
