Subject: Concurrently Enrolled Students-Fall 2012

The National Student Clearing House (NSCH) provided a report on concurrent enrollment in fall 2012. De Anza College submits enrollment data to NSCH as part of a federal requirement for financial aid and we use their services to track student transfers.

NSCH defines concurrent enrollment as a situation in which a student is enrolled at two or more schools and the enrollment overlaps within at least 30 days. The tables below highlight their main findings.

- 80% of De Anza students concurrently enrolled at another college are enrolled at a Two-Year Public college and 17% are enrolled at a Four-Year Public college.
- Less than 1% of De Anza students concurrently enrolled at another college are enrolled at a For-Profit institution.

- Foothill College enrolls the highest number of our concurrently enrolled students, 41% of total concurrent students.
- San Jose State enrolls the highest number of De Anza full-time students who are concurrently enrolled at both colleges.

Methodology:

The financial aid office reports student enrollment to NSCH three times per quarter, at census, mid-quarter and after the quarter ends.

Only students with a valid social security number are included. Therefore, international students and non residents are not included. Students who did not enter their SSN or entered an invalid SSN on their admissions application are not reported to the Clearinghouse.

Apprenticeship students are not reported to the Clearinghouse.

Since the report was published prior to the end of our fall term, it is assumed that the NSCH report is based on our fall census enrollment report.
