FHDA Student Financial Aid Trends, Winter 2004

Data Extracts as of February 23, 2004 compared to February 1 and April 15, 2003

District

- New applicant processing and outreach efforts have contributed to increases in the number of students receiving aid so far in 2004, compared to a similar period last year.
- The District has awarded nearly 1,000 additional students financial aid compared with a similar period last year – a 15% increase.
- Both campuses have posted significant increases in BOG, Pell and Loan recipients.

De Anza College

- > Pell Grant recipients are up 22% (2,043 this year vs. 1,681 last year in February).
- ▶ BOG recipients are up 12% (4,741 this year vs. 4,238 last year end of Fall).
- ▶ Loan recipients are up 39% (551 this year vs. 395 last year, mostly in Stafford).
- 8,227 total applicants have already exceeded last year's total of 7,667 and we still have four more months to receive applications for this year.
- The unduplicated number of students receiving aid is up 14% (5,053 this year vs. 4,450 last year in Feb).

Foothill College

- > Pell Grant recipients are up 6% (468 this year vs. 442 last year in February).
- ▶ BOG recipients are up 39% (1,897 this year vs. 1,362 last year end of Fall).
- ▶ Loan recipients are up 10% (415 this year vs. 330 last year, primarily in Stafford).
- Total applicants in February last year were 2,626. This year in February we are at 3,030, a 15% increase.
- The unduplicated number of students receiving aid is up 31% (2,106 this year vs. 1,611 last year in as of 4/15/03).
