SUBJECT: Summer Enrollments

Please find below information that was requested on summer enrollments at FHDA.

- About 60% of students enrolled in summer 2009 returned in fall 2010 (Figure 1). 24% or 6,967 students had enrollment only in summer (Figure 2). About 9,800 summer students (1/3) were potential transfer students (Figure 2).

- A start date of July 6, 2010 for the 8 week session ending on August 26, 2010, would likely result in overlap with several local universities on the semester system, including SJSU and Berkeley.

- Data from the National Student Clearing House indicate that about 2,700 summer students attended one of more than 200 four year colleges from around the country in fall 2009. San Jose State University, UC Davis, San Diego, Berkeley, and Santa Cruz were amount the top public transfer colleges. A number of students also attended Santa Clara University and Stanford.

In summary, the vast majority of students attending the summer session are “native” FHDA students, but there are nearly 1,000 students that normally attend semester institutions such as SJSU or Berkeley in the fall, that would be negatively impacted by the proposed summer 2010 start date of July 6.
