



UC DAVIS TRANSFER ADMISSION GUARANTEE (TAG) - FALL 2018

(EOPS and International students must work with their respective programs)

Step 1: Complete the TAG Eligibility Self-Assessment Questionnaire below:

ANSWER "YES," "NO," OR "N/A" FOR EACH QUESTION BELOW: (N/A = not applicable)

1. At the time the TAG is submitted will you be enrolled or planning to enroll at a baccalaureate or other non-California community college institution prior to transfer to UC Davis?[^]
2. If you previously attended a baccalaureate institution, will you have 120 transferable quarter units or more of combined university and community college coursework (after applying UC lower-division unit limitations and exclusions – see page 3 for details)?*
3. Are you a former UC student who left the University when not in good standing?
4. Are you a former UC Davis student (not including summer session)?
5. Do you possess a BA or BS (or higher level) degree?
6. Are you currently working towards high school graduation and will graduate after summer 2017?

If you answered "yes" to any question #1-6 above, you are not eligible for a UCD TAG – consult with UC Davis and apply through the regular admission process.

7. Were you enrolled full-time+ at a California community college spring term 2017? (Note: students attending high school in spring 2017 must simultaneously be enrolled with part-time or full-time status at a CA community college.)
8. Will you be enrolled full-time+ at De Anza this fall 2017 and do you plan to be enrolled full-time+ through spring 2018?
9. Will you complete, or have you completed, a minimum of **45 UC transferable quarter units by the end of summer 2017?**
10. Will you complete a minimum of **90 UC transferable quarter units**, with at least 45 of those units taken at a California community college, by the end of spring 2018?
11. **Will you have the two transferable English courses (UC-E) and one transferable math course (UC-M) required for admission completed, with grades of "C" or higher, by the end of fall 2017?** (See back for course list)
12. Will you complete all courses required for minimum UC eligibility by the end of spring 2018? (See back for requirements)
13. Will you complete all courses required for a selective major by the end of spring 2018? (See back for selective majors)
14. At the end of summer 2017 will you have a minimum UC transferable GPA of: (See back for additional requirements for selective majors)

If you answered "yes" or "NA" to questions # 7-16 above, you may be eligible for a TAG. Continue to Step 2.

Step 2: If you believe you are eligible for the TAG based on your answers to the questions above, carefully read this entire 4-page document for TAG procedures and requirements. Compile all of your transcripts and (if applicable) Advanced Placement (AP) or International Baccalaureate (IB) exam scores. (See pages 3 and 4 for details) Log-in to the UC Transfer Admission Planner and start working on your UC Davis TAG application.

Step 3: Attend a UC TAG Information Session. (Optional, but highly recommended) Information sessions will begin in July and the schedule will be available at: www.deanza.edu/transfer/. You may also see a counselor/adviser to address specific TAG questions. Staffing in the Counseling & Advising Center is limited during the summer and early fall. Step 4: Submit the UC Davis TAG Application online (within the UC Transfer Admission Planner system) between **September 1-30, 2017**
Important Notice: TAG reviews are based on your self-reported information only. It is your responsibility to make sure the information you report is accurate and complete. See page 4 for helpful information.

Step 5: Check the UC Transfer Admission Planner system ('My Messages' tab) and your email for messages. Respond to all requests promptly and follow all directions. Your TAG may be at risk if you fail to respond to requests. Review the information provided on the "TAG Decisions" page:

Step 6: Submit your UC Application for Undergraduate Admission between November 1-30, 2017.

UC Transfer Eligibility Requirements (see www.ASSIST.org for course limitations) (WARNING: courses listed below may not be on IGETC)

- Two UC-transferable courses in English composition (Area UC-E). De Anza courses include: EWRT 1A,1AH,1B,1BH,1C,2,2H,PHIL 3,COMM (SPCH) 9
- One UC-transferable course in mathematical concepts and quantitative reasoning (Area UC-M).
De Anza courses include: MATH 1A, 1AH, 1B, 1BH, 1C, 1CH, 1D, 1DH, 2A, 2B, 10, 10H, 11, 12, 17 (57)*, 22, 23, 43, 44, PSYC 15, SOC 15
*Students must complete both Statway courses; MATH 57 is UC transferable if taken during the 2014-15 academic year or later. MATH 57 was renumbered to MATH 17 effective fall 2016.
- Four courses selected from at least two of the following Subject Areas:
 - ♦ Arts and Humanities (Area UC-H)
 - ♦ Social and Behavioral Sciences (Area UC-B)
 - ♦ Physical and Biological Sciences (Area UC-S)

SELECTIVE MAJORS BELOW – The minimum GPA and coursework listed below are required for admission. Courses must be completed for a letter grade by the end of spring quarter 2018. Selective major courses completed at the time the TAG is written must have been completed with C grades or higher; course repeats in-progress and planned will not be considered for TAG.
For additional course work in your major, see www.assist.org For the best transition and reduced time-to-degree, students should consider completing all lower division preparatory coursework shown on www.assist.org for their intended major.

NON-SELECTIVE MAJORS – For majors not listed below, see www.assist.org for lower division major coursework. For all majors, both selective and non-selective, the minimum GPA is required at the time the TAG is written and must be maintained throughout the remainder of all transfer work with no grade less than “C.”

- **BIOLOGICAL SCIENCES, COLLEGE OF:** 3.2 overall UC transferable GPA. 2.5 GPA in each group of courses with no grade less than “C” and must have the 2.5 for the course(s) in each group that have been completed when the TAG is submitted. (MATH 1A/1AH, 1B/1BH); (CHEM 1A, 1B, 1C); (BIOL 6A/6AH, 6B, 6C/6CH). Minimum GPA must be achieved in course(s) completed when TAG is submitted.
Strongly recommended: CHEM 12A, 12B, 12C; PHYS 2B, 2C (courses must be taken for letter grade and no grade less than “C”, but grades will not be assessed as part of the required GPA for major course groups).
- **BIOTECHNOLOGY:** 3.2 overall UC transferable GPA. 2.5 GPA in each group of courses with no grade less than “C” and must have the 2.5 for the course(s) in each group that have been completed when the TAG is submitted: (MATH 1A/1AH, 1B/1BH); (CHEM 1A, 1B, 1C). Also required: BIOL 6A/6AH with a “B” or higher. BIOL 6ABC series completion is highly recommended as it is a prerequisite for many upper-division courses. If two courses or entire series are completed, a group GPA of 2.5, with no grade less than “C” is required. Minimum GPA must be achieved in course(s) completed when TAG is submitted. Strongly recommended: CHEM 12A, 12B, 12C.
- **COMPUTER SCIENCE:** 3.2 overall UC transferable GPA. 3.4 GPA in each group of courses with no grade less than “C” and must have the 3.4 for the course(s) in each group that have been completed when the TAG is submitted. (MATH 1A/1AH, 1B/1BH, 1C/1CH); (MATH 22, (CIS 22A or 26A or 26B or 35A or 36A), CIS 21JA, CIS 22C/CH).
- **ENGINEERING, COLLEGE OF:** 3.3 overall UC transferable GPA. Must complete all lower division engineering courses required for admission by the end of spring quarter 2018 with a 3.2 and must have the 3.2 for the courses from that group that have been completed when the TAG is submitted. Courses must be completed with a letter grade and no grade less than “C.”(See www.assist.org) Note: UCD will honor engineering articulation that’s posted on ASSIST for 2016-2017 with these exception: (the following exceptions are specific to De Anza’s agreement with UCD. If you completed coursework at another CCC, please reference ASSIST and UCD TAG criteria at <https://www.ucdavis.edu/admissions/undergraduate/transfer/transfer-admission-guarantee/criteria/> for information) For Aerospace Engineering, PHYS 4D is no longer required. For Chemical Engineering, ENGR 35 or ENGR 37 is required. For Electrical Engineering, (COMM (SPCH) 1/1H or 16/16H) and (EWRT 1A/1AH or 1B/1BH or 1C)# are recommended before transfer. For Environmental Engineering, required courses for admission are: MATH 1A/1AH, MATH 1B/1BH, MATH 1C/1CH, MATH 1D/1DH, MATH 2A, MATH 2B, CHEM 1A, CHEM 1B, CHEM 1C, PHYS 4A, PHYS 4C, ENGR 35, (CIS 22A or 26A or 26B or 35A or 36A), GEOL 10, (EWRT 1A/1AH or 1B/1BH or 1C)#. For Mechanical Engineering, PHYS 4D is no longer required; (COMM (SPCH) 1/1H or 16/16H) and (EWRT 1A/1AH or 1B/1BH or 1C)# are recommended before transfer.
For certain majors, the College of Engineering requires one English course as part of its lower division preparation. However, UC requires two English composition (UC-E) courses for admissions eligibility.
- **PRE-LANDSCAPE ARCHITECTURE:** 3.2 overall UC transferable GPA, be willing to arrange TAG for “Pre-Landscape Architecture” and apply in the Landscape Architecture (Pre-) category of the UC Application for Undergraduate Admission. A portfolio must be submitted in February before or after enrollment at UC Davis. Contact (530) 754-8628 or visit <http://humanecology.ucdavis.edu/lda/> for portfolio details. TAG does not guarantee admission to the major.
- **PSYCHOLOGY:** 3.2 overall UC transferable GPA. 2.9 GPA in the following courses with no grade less than “C” and must have the 2.9 for the group of courses that have been completed when the TAG is submitted: PSYC 1; MATH 10/10H or PSYC 15; BIOL 6B or (BIOL 10/10H and ANTH 1/1H) or (BIOL 10/10H and BIOL 40ABC).
- **VITICULTURE & ENOLOGY:** 3.2 overall UC transferable GPA and 3.0 in the following group of courses with no grade less than “C”:
CHEM 1A, 1B, 1C; MATH 1A/1AH; PHYS 2B, 2C; BIOL 6B. Must have 3.0 for the group of courses that have been completed when the TAG is submitted. Strongly recommended: MATH 1B/1BH; if taken, the 3.0 GPA requirement also applies to this course.

UC Davis TAG Timeline, Requirements and Special Notes

Student Name

You must use your full legal name on the UC TAG Application and the UC Application for Undergraduate Admission; consistent use and spelling of your name is crucial. Your name must also match the name appearing on De Anza records.

Grade Point Requirements

- 1) The minimum overall grade point average (GPA) for transferable work required for a TAG varies by College as follows:
3.2 for the College of Agricultural & Environmental Sciences and the College of Biological Sciences and the College of Letters and Science
3.3 for the College of Engineering
- 2) You must have this GPA at the time your TAG is initiated and submitted, and must maintain it throughout the remainder of your transfer work with no grades below a "C".
- 3) Courses required for selective majors must be taken for a letter grade. AP and IB exams with valid scores are acceptable when comparable to UC Davis course equivalencies. Timeline for Course Completion

- 1) To qualify for a UC Davis TAG for fall 2018 the following specific required courses must be completed by the end of spring 2018:
 - those required for UC Transfer Eligibility (but the two English and the one math must be completed by the end of fall 2017)
 - those required for admission into selective UC Davis majors
 - those required to complete 90 UC transferable quarter units
- 2) Summer 2018 session may not be used to complete courses required for admission. Students who have completed all requirements by the end of spring 2018 may use the summer to take supplemental coursework that will enhance their preparation for UC, including completion of the IGETC. Students considering attending a 4-year institution must make sure they don't exceed the maximum transferable unit limit referenced at the bottom of this page. Those considering a UC summer session prior to transfer should be advised that they must obtain "C" grades or higher to remain in good standing at UC.

Transcripts (domestic and outside of the US)

- 1) You must self-report online, each college or university where you were previously (and currently) enrolled or attended, including enrollment and attendance in English language programs. You must be prepared to provide UC Davis with transcripts verifying enrollment and attendance in English language programs upon request.
- 2) If you attended a college or university outside of the United States, the correct name and address of each international school must be reported online. You must be prepared to provide UC Davis with transcripts (with grading rubrics), course descriptions, AND word-for-word English translations of both documents upon request.
- 3) If you are admitted to UC Davis you must be prepared to submit official De Anza transcripts to UC Davis by July 15, 2018. (Note, this extended deadline applies to De Anza because we're on the quarter system. Check with Foothill and Lake Tahoe CC if applicable. All other official final transcripts (college, university, high school) must be submitted by July 1, 2018.) **It is critical that coursework self-reported on the UC TAG Application and the UC Application for Undergraduate Admission matches with coursework on the official, sealed transcripts.**

Exam Scores

If exams were taken, you must self-report online scores from AP and IB Higher Level Examinations. Students admitted to UC Davis should be prepared to submit official exam scores to UC Davis by July 15, 2018 (strongly encouraged by July 1). It is critical that scores self-reported on the UC TAG Application and the UC Application for Undergraduate Admission match the official exam scores. Prerequisite Course Requirements

UC Davis assumes you have met prerequisites to qualify for TAG course requirements, especially in the areas of English and math. UC Davis may request additional documentation verifying prerequisites were satisfied.

Missing lower-level courses within series

If you completed advanced-level courses without completing corresponding lower-level courses within a series, you are advised that you may be missing important subject matter considered comparable to UC Davis course content and may be required to complete additional coursework at UC Davis to meet graduation requirements. Regarding sequential math and language other than English (LOTE) courses: advanced level course completed with a "C" or better validates the missing lower-level course. TAG applicants in selective majors requiring mathematics must meet specified course group GPA requirements. Regarding sequential chemistry courses, TAG applicants in selective majors requiring chemistry who meet specified course group GPA requirements will be reviewed by the college on a case-by-case basis for an admission recommendation. Physics courses are NOT considered sequential.

Lower-Division Unit Limitations/Excessive Units

You will be granted up to 70 sem/105 qtr units of credit for lower division coursework completed at any institution or any combination of institutions. For units beyond the maximum, subject credit for appropriate coursework taken in excess of this unit limitation will be granted and may be used to satisfy requirements. If upper division coursework was completed, please check with a counselor or adviser to determine if you are at risk of being denied admission due to excessive units.

- Units earned through: AP, IB, and/or A-Level examinations are not included in the limitation and do not put applicants at risk of being denied admission.
- Units earned at any UC campus (Extension, summer, cross/concurrent and regular academic year enrollment) are not included in the limitation but are added to the maximum transfer credit allowed and may put applicants at risk of being denied admission due to excessive units.

California Community College (CCC) Enrollment Status

You MUST have been enrolled at a CCC spring 2017. You must be enrolled fall 2017 at the current/primary CCC you indicate on your TAG Application. Full-time enrollment at a CCC from spring 2017 through spring 2018 is expected, though part-time enrollment is permissible with good cause. This policy also applies to students attending high school spring 2017. Students enrolled part time at a CCC should provide a brief explanation about reasons for part-time attendance in the section of the UC TAG Application titled "Additional comments regarding TAG application" that becomes available during Step 1 of the TAG submission process. The UC Davis representative has the sole discretion to make exceptions to the full-time status requirement. (Similarly, non-enrollment status for winter/spring 2018 terms may be considered by UC Davis if you are not enrolled anywhere, have met all requirements, and are academically well prepared for the rigors of UC coursework. Reason for non-enrollment must be reported on the TAG Application.)

UC Application

If your TAG is approved you must submit the UC Application for Undergraduate Admission November 1-30, 2017 for the same major on the TAG. Information on the UC TAG Application and UC Application for Undergraduate Admission must match. You must also complete the UC Transfer Academic Update (TAU) see www.universityofcalifornia.edu/afterapply providing grades and course changes as directed, by the specified deadline.

Courses Offered by California Community Colleges (CCC)

You must take courses equivalent to UC Davis courses if they are offered at De Anza. Courses not offered at De Anza must be completed after enrolling at UC Davis. When www.assist.org states that there is "NO COMPARABLE COURSE" or "NO COURSE ARTICULATED" UC Davis will waive that course requirement for the TAG. If a course is not offered at De Anza, UC Davis encourages you to seek comparable courses at another CCC when possible and to include comments in the TAG Application when unable to enroll in required courses.

Reporting Coursework/ Gaps in Education/ De Anza Review

The UC Transfer Admission Planner System instructs you to list in chronological order **ALL** college and university courses (including summer session and extension courses) for all terms you have attempted or completed (including courses you repeated or in which you earned a D or an F, I for incomplete, or W for withdrawal), regardless of grade, length of attendance or whether you think the courses will affect your chances for a TAG. Enter your grades exactly as they appear on your records. Refer to grade reports and transcripts; do not work from memory. Be sure to include courses that are currently in progress and planned for future terms. **You must also report and explain any gaps in your education.**

You will be reporting UC transferable courses completed at a CCC via a drop-down menu and course-list displayed in the Planner System. All other courses will have to be manually typed into the system. You must transpose the course information exactly as it appears on the transcript. One exception is regarding the campus identifiers (D=De Anza, F=Foothill) attached to Foothill-De Anza's courses appearing on DegreeWorks and unofficial transcripts (e.g. EWRT 211 will be listed as EWRT D211). Please report the proper course number (e.g. EWRT 211) by dropping the campus identifier in these cases. Remember, you should only be manually typing in CCC courses that are not UC transferable and courses taken outside of the CCC system.

Before forwarding your TAG to UC Davis, a De Anza counselor will do a cursory check for minimum TAG eligibility in order to provide UC Davis with a recommendation. Do not rely on this review to have your work checked or to determine your TAG eligibility. You will only receive feedback from De Anza if there is some element on your Planner that needs to be clarified. UC Davis has the final decision regarding your TAG. ALL TAG Applications will be forwarded to UC Davis regardless of the outcome of De Anza's review. Note: TAG reviews will be based on your self-reported information ONLY. Transcripts and exam scores will not be referenced. It is your responsibility to make sure the information you report is accurate and complete.
