COURSE OBJECTIVES:

This course is the second of a three course series at De Anza College; the first two courses cover financial accounting and the third course deals with managerial accounting. Accounting 1B course will cover fixed assets, payroll and current liabilities, investments, corporations & partnerships, long-term liabilities, cash flow statement, and financial statement analysis. We will cover Chapters 10-17.

The **primary objective** of this course is to help students learn how accounting meets the information needs of various users by developing and communicating information that is used in decision-making. Accordingly, the expected student outcome is the demonstration that the student can prepare, analyze, and interpret financial statements.

Strategic learning outcomes: 1. Demonstrate a knowledge of the users of accounting information and forms or business ownership, risks and capitalization of each and prepare, analyze and evaluate the financial structure of a firm using corporate financial statements (and include the statement of cash flows). 2. Analyze and evaluate the capitalization of a firm using debt and equity and apply net present value methodology to the analysis.

COURSE EXPECTATIONS:

This course is a lecture course to introduce new topics and to review assignments. I will take attendance for the first two weeks of class as required by California regulations. Beyond the first two weeks, it is your choice as an adult to attend class and show up on time. Arriving late or leaving early is disruptive to the class. **Regular attendance is both encouraged and is expected**. If your attendance in class is high, a higher course grade may be achieved.

If you decide to drop this class, YOU must do so in a timely manner. I will not drop you. Keep in mind the final drop date for a "W" (Friday Nov 14, 2014).

Any **misconduct** which in the view of the instructor is deemed to be a disturbance to the class and a distraction to the other students will result in the **dismissal** of that particular student from the class.

Students are expected and encouraged to read the current chapter in the text before coming to class on the day that the lecture/discussion is scheduled. **Note:** the instructor reserves the right to make changes in the course schedule and learning activities as deemed necessary.

METHOD OF EVALUATION:

Final grades will be determined by homework assignments, unannounced quizzes and in-class group projects, 2 midterms, and one final comprehensive exam. Both exams and quizzes may consist of either multiple choice, problem solving questions, and/or fill-in, short-answer questions. Midterm exams and final exam will be **solely individual**.

You should keep track of all of your assignment grades. I will post your assignment grades on Cengage but you must calculate your grade manually. Refer to <Points System> Excel spreadsheet to calculate your grade.

Homework – 15% grade

Assignments and due dates will be announced in class and are due as scheduled. You will have one week to complete each assignment. Homework will be on-line on Cengage. The online homework will be graded by the Cengage Learning software and I will review manually as necessary. No late homework will be accepted. I am unable to provide tech support for Cengage. If you are having issues, make sure you are using a modern browser (Chrome, FireFox, etc), try disconnecting from VPN software if in use, restarting your computer, or trying a different internet connection. If you are unable to submit the assignment online due to technical issues, print the assignment and bring it to class on the scheduled due date. There are no makeups, however, there will be more than 100 points available in case you would like to increase your homework points. A max of 100 points will be allocated for homework even if extra assignments are completed.

Quizzes and Group Projects – 15% grade

Chapter quizzes may or may not be announced. These in-class quizzes will be closed book and closed notes. There will be one-day group in-class assignments. There will be no makeup for missed quizzes or group-projects, however, there will be more than 100 points available. A max of 100 points will be allocated for quizzes and group projects. You do not need scantrons for quizzes.

Midterms and Final - 70% grade

There will be two midterms and a comprehensive final exam. The lowest midterm exam grade will be dropped. The comprehensive final exam is mandatory. You will need to bring no. 2 pencils and a green 100 question scantron for each exam. A 10-key calculator will be allowed; no graphing calculators or cell phones will be permitted. There will be extra credit available on the exams. No individual makeup exams will be allowed.

Extra Credit - additional 3%

In addition to the extra credit problem(s) on the exams, you will be given the opportunity to earn up to 8 extra credit points by completing the assigned study tool for each chapter on Cengage. For each chapter study tool, you will take a pre-test, and based on your results Cengage will suggest chapter readings and assignments to improve your score and knowledge of the chapter. When you are ready, you will take a graded post-test. You **must score at least 75%** on the post-test to receive credit for that chapter. No credit will be given for the pre-test. 1 extra credit point will be earned for each chapter assignment completed with a score >75%.

Students who do the homeowkr assignments and read the material prior to class do significant better than those that don't put in the effort. If you are to do well in this course, you should expect to put in two to three hours of concentrated study outside the classroom for each hour in the classroom.
