#### **Business Items**

1. DISCUSSION/ACTION

Title: La Voz Travel Line-Item Transfer Request This item is to discuss and approve a line-item transfer request for La Voz (Account # 41-56500) in the amount of \$1,500 from Code 4060 (Printing) to Code 5510 (Domestic Conference and Travel) pay for the three-day ACP-JACC conference in San Francisco. Conference registration, 3-4 nights at the conference site in Hyatt Regency Hotel and transportation for six students. March 9-11. Deadline is Feb. 21. Presenter: Farideh Dada Time: 10 minutes Farideh: We appreciate DASG for all your support for La Voz! The slogan for this conference is: "Empowering Student Journalism." We appreciate a line item transfer from our unused Printing (4060) funds to our Domestic Conference & Travel (5510) Funds

Amy: Is there a foreseeable future where printing returns?

Farideh: It depends on student interest, last quarter it didn't happen but it may this quarter. La Voz is still partially online, the most recent meeting was held online so it's still up in the air. We're targeting to at least print one issue, however.

Amy: If printing resumes, what happens to the already transferred funds? Printing funds will be 0.

Farideh: We will request funding from other sources, estimated cost at \$500.

# 2. INFORMATION/DISCUSSION/ACTION

Title: Feedback from Student Success Center (Tutorial Services) Regarding DASG Funds This item is to present and discuss feedback from the Student Success Center (Tutorial Services) regarding DASG Funds.

Presenters: Izat Rasyad and Amy Huang Time: 15 minutes

Izat: Discussed budget cuts for the SSC: TS. DASG cutting the budget to force the college's hand to fund the SSC: TS is not something that happened just recently. It's important that we discuss our actions moving forward. Re-allocating budget at the district level from Foothill to De Anza.

Amy: Used to fund \$200,000 per year, historically we fund half of the SSC's student salaries. SSC also applies for grants outside of DASG funds, they juggle around 3-4 funds yearly to keep the program afloat. College funds all coordinator salaries and a small B-Budget fund: 9 coordinators @ 100,000.00 each, B-Budget for office supplies etc. DASG funds strictly student payroll. Decision will impact the number of services, tutors, and hours. Last year's cut caused one-one sessions for Math 1A and higher to be removed, such sessions now only offered for Precalc. Foothill has nearly double the B-Budget De Anza has, hope for discussions of transfer at the college district level.

TJ: After the first reading of the budget @ the Senate meeting, numerous comments against this action arose.

Amy: Numerous changes in the budget: New classified position in the flea market etc. Tutoring is a basic need for students. Needs between programs vary. For example, accounting tutoring only has one tutor at a time and there's always a long line of students. CIS department also couldn't afford to offer more than 2 tutors despite the Hyon Chu: The committee should feel comfortable articulating that we are investing in our internal structure. We've neglected our organization for all these years and it's now a need more than ever to re-invest in ourselves. Amy: We can help the program find funds, grants, etc., or ways to make money through our own events for our own revenue despite decreasing enrollment.

Amy: We can offer ideas for those that sit on PAC. Make sure that upcoming year's representatives are properly onboarded. Most shared governance meetings are public, interns are advised to reach out to TJ to get appropriate details.

#### 3. INFORMATION/DISCUSSION

Title: 2023-2024 DASG Budget Stipulations This item is to review and discuss potential revisions to the DASG Budget Stipulations. Presenter: Dennis Shannakian Time: 30 minutes

TJ: We may make amendments for item 12, I vouch for promotional items Dennis: With a cap of \$50 without tax of promotional items per item per person. Amy: I arrived at \$50 because the Senate sweaters were priced at \$42 each. Lisa: I don't suggest overseas purchases: sales tax and shipping from overseas vendors are costly.

Dennis: I had a thought that we can make amendments for item 13 as student body funding includes banquets whereas tutorial services and other essential services are not Amy: I suggest a change from "banquets" to "graduations."

Lisa: Years ago DASG did support a little bit of funding for the campus-wide graduation, we funded water and a few snacks for graduates. This is the entire student body, not just a single program.

Hyon Chu: I agree with funding for these events since most of these programs don't have stable funding. At these events, we should show our support, it's the achievement of our students. We shouldn't just fund one population of students out of others. Amy: I suggest a 20-minute recess for everybody to go to suggestion mode and edit the document, I feel this is a more efficient process. Dennis: Sure

Amy: What exactly do essential services entail?

TJ: We can give an exact definition for this term.

Dennis: We can update the website, add a page where people can go to.

TJ: A 2-week notice for marketing requests.

Dennis: I agree- For number 11, we should double check these amounts yes. There should be an increase from the previous amounts. Those numbers may be too low for today: 1,200.00 per speaker per event, \$1,800.00 per performance

Hyon Chu: Yeah we should consider raising that to closer to \$3000.00 per

speaker/performance per event, that makes more sense. I may even push for \$5000.00. Amy: I'm not sure if we're able to even fund that much.

Dennis: Of course, but according to today's rates etc, these numbers are just not reasonable. I push for \$3000.00 per speaker or performance.

Amy: For number 12, I put in \$25 as a place holder but I can log in to FedEx and UPS to find the pound amount, shipping has almost doubled since 2020. But then again, for

example: it doesn't make sense if someone orders 10 hoodies and pays \$250 for overnight, I was thinking of finding a percent amount also.

Dennis: For item number 13: why add a cap, adding a cap is how much you would fund then. It would be unnecessary and it would just keep your hands tied. Imagine trying to give more funding for an event, you would have to change the entire Budget Stipulations.

Amy: I would honestly just keep it as is.

Dennis: Let's exclude Summer for item 15.

Amy: Agreed

Dennis: Fix wording for item number 23 and 25

TJ: Item number 37?

Dennis: The purpose of this item was so for we wouldn't need to pay for the class, the college is supposed to be funding that. I see that Jason Bram's marine program is something that is instructional however, let's find proper wording for it. Isaac: "Excluding supplemental programs for students for example: conferences and

field trips"

Dennis: Sounds good
