<u>Approval of Minutes</u> Wednesday, November 10th, 2010

Sana Kathuria moved to approve the minutes as amended. Lena Ghamrawi seconded the motion. The motion passed by consensus.

Public Announcements

The Lady in charge of the Euphrat Museum of Art thanked the Senate and invited the Senators to the upcoming event on Saturday, where games in teams will be offered.

Senate Announcements

- Ismail Desouki announced that there were 35-30 people needed to fill a classroom regarding the filming for the Pepsi Refresh Project on this Friday. He informed the Senate that the filming would start at about 12.00pm after the SRS meeting and passed around a sign-in sheet.
- Thoa Hoang announced that there was a new policy and to contact Adam to hear more about it.
- Alison Chan announced that there would be a movie night on next Monday at 6.30pm in the Conference room and passed around a sign-in sheet.

Internal Reports

- The Environmental Sustainability Committee did not have a meeting last week, so there was no internal report.
- Adam Coquia from the Marketing Committee announced that there will be a DASB E-Newsletter established to inform its readers about DASB sponsored events and programs and it will also address student concerns given to Student Rights and Services. The committee announced that they had discussed a consistent publication timeline of when the newsletter will come out and talked about places it will be promoted, e.g. the Senate website. Second, the Marketing Committee announced that the Flyers for the Diversity and Events Movie Night Advertising would be done by Thursday and that Marketing representatives had presented the item at the ICC meeting. Last, Adam Coquia informed the Senate that they had restructured the Marketing Committee to establish a solid system of review for each marketing event and to make the Marketing Committee even more

efficient.

- Leo Nguyen from the Finance Committee announced that they recommended the Senate to fund for the Pepsi Refresh Project and the Campus Camp Wellstone Event on this week's Finance Meeting on Monday, November 15th, 2010. He also suggested making the Campus Camp Wellstone Event an urgent item for the next Senate meeting. He announced that the Finance Committee chose Saturday, January 15th, 2011, and Saturday, January 22nd, 2011, to hold the Budget Deliberation, and that they still needed to more Senators to be in the Budget Team. Last, he thanked Victoria Nguyen for finishing the whole Finance Workshop.
- Lena Ghamrawi from the Diversity and Events Committee announced that that they had finalized the details for this Friday's Insomnia 2.0 Fall Dance with ICC. She passed around a sign-up sheet for Senators who wanted to help set up everything for the dance. They had also been working on ideas for the Pepsi Refresh Project and other events in January, and they planned everything for the Movie Night on Wednesday, November 24th, 2011, after the Senate meeting.
- The Student Rights and Services Committee announced that they did not have a meeting last week because the day was off. They said that discounts were still being added and that they were exploring more options for Kirsh's Kitchen. They also announced that the Student Rights and Services Day Camping went well and asked everyone who went to pay \$10 as soon as possible. Last, they announced they were still looking for people to talk to teachers for the TA program.

- Wayne reminded the Senate that prospective tutors have to take an extra class in order to become tutors, which costs them a lot and requires a lot of work as a tutor to be evened out.

Senate Announcements

- Brenden Fant explained why he did not vote yes on the Pepsi Refresh business item. He saud he wanted the Senate as a whole to contribute making the project successful.
- Ahmad Fayad announced that even though printer in the Senate Office is broken, he is not going to order another printer, because a lot of people are still printing out their homework and other things that are not Senate related. He reminded the senators to not abuse the printer for private interests, otherwise he would not replace it.
