\$2 Student Representation Fee







Student Senate for California Community Colleges

- Political roots go back to the 60s where it was built through student power
- Statewide student organization recognized by the BoG
- Represents 2.3 million community college students in 114 California community colleges

• Shared Governance at a statewide level

- Structure
 - 10 Regions
 - 3 Senators each
- Annual budget of ~\$60,000 from CCCCO just to meet once a month in Sacramento

A Brief History

- California Ed. Code 76060.5 amended by AB 1725 signed by Governor George Deukmejian in 1988 established a \$1 SRF, to be collected by the ASO for statewide student representation
- Opened the doors for advocacy at state, county, city and local campus levels, only to be used by ASO

What is the \$2 SRF?

- Introduced through Assembly Bill 1358 in 2013 by Assemblyman Paul Fong & Emily Kinner, amended State Ed Code
- \$1 goes to the Student Senate for California Community Colleges
- \$1 goes to the local Associated Student Organization DASB
 - Conferences put on by the Student Senate for California Community Colleges (SSCCC)
 - Legislative visits
 - Local ASO efforts
 - \circ $\;$ Travel for conferences, events, and legislative visits
 - "March in March"
 - \circ General student support
 - Any other student advocacy program or conference

Why adopt the SRF at De Anza?

- Demonstrate De Anza's commitment to bolstering student representation and organization throughout the state
- Reinforce our leadership role among community colleges and enable us to have greater influence over the future development of the SSCCC
- Increase De Anza students' capacity to exercise influence on decision-making at the state level
- Earmark funds specifically for advocacy and representation purposes
- Whether to adopt the SRF should be put to the student body -- an election on the proposal will inform students about the SRF and empower them to make a democratic, collective choice on its merits
- Dahlia Salem said De Anza is a really politically active campus, good resources to train student leader and organizers.
- John said there would be a separate form to opt out the \$2.
- Thao asked who would be in charge of getting students to vote.
- Naeema said we will recruit student volunteers from Political Science and Civic Engagement classes to have good turnout voter.
- John said if senate votes to have a special election for SRF fee that means senate endorses the fee.
- Naeema said administration expenses would only be allowed to 7.5%.
- Kush said he would feel more comfortable to make decisions if we have all the information in the table.
- Naeema said we want to open more opportunities for student to represent us.
- Naeema said we are not allowed to vote for only \$1 fee.
- Mia moved to have a special election for \$2 Student Representation Fee

 Seconded by Mina
- Kush asked what specifically the student advocacy programs are being mentioned in the PowerPoints.
- Dahlia said the Board of Governors would be much harder on SSCCC than the student senate.
- Arjun said we need student's voice at the table one state in, \$1 for every student each quarter for SSCCC is really necessary.
- Vin said it is essential to understand our voices are heard, this vote allows the student bodies to participate in the process.



• Arjun presented





- Structural Concerns at Flint Center & Garage
- \$12 \$24 million to renovate as-is
- Rebuild Garage: 1,000 stalls @ \$40,000/stall = \$40mm
 - Various forms of financing exist, generally requiring \$2mm / year in annual payments
 - Assumes mechanical ventilation and fireproofed for "wrapped garage"
- "The Oaks" on Stevens Creek recently sold at

approximately \$6mm/acre; to be redeveloped as mixed-use with 200+ residential condominium-style units

- Highly suggest subsidized student housing, especially for international students.
- Flint Garage should remain until a new parking structure is built in order to alleviate parking shortage.

Integrated transit facilities should be considered in any new structure.

FLINT CENTER

Financial Performance:

- Underutilized in terms of capacity
 - Despite capacity for 2,400, average attendance has been 900-1400 from 2013-15
- Overbuilt for the demands of the market
- Average annual net loss of \$82,453 over the previous four years

Based on the Brailsford and Dunlavey report 'cons,' reject further exploration for development of partnerships in on-campus housing, retail, and/or office space.





Factors to be Considered in Option Analysis

- Execute option 6B presented at September Board Meeting.
- Tear down Flint Center to provide space for new development.
- Create a transit center in the lower level of the new garage.
- Mark out wider parking spots and increase the number of Carpool and Alternative Fuel parking spots in a newly-constructed garage.
- If Flint Center is demolished, to install a small memorial of it inside any newlyconstructed buildings on that site, like a glass display or a plaque."
