#### 2. INFORMATION

Title: Cupertino for All, Student Housing, and the 2022 Housing Element Update Description: Informational item for learning about the coalition work of Cupertino for All as it pertains to student housing needs and addressing our housing crisis.

Time: 10 Minutes

Presenter: Neil Park-McClintick

- ⇒ Neil P: Land use forms community and impacts lives. Cities are essential in regarding to housing prices and decide how all the land is used. Only about 5% of De Anza's students live in Cupertino. Students are rarely engaged in Cupertino politics. Housing element-part of city's general plan. First ever housing element cycle where cities must explain how they're going to further fair housing. 3% Latino population vs 31% San Jose population is an example of the socioeconomic desegregation; must create more integrated and equitable communities.
- ⇒ Sharon U: I move to extend time by 10 minutes.
- ⇒ Anita C: I second. No objections.
- ⇒ Neil P: Sample e-mail to include De Anza students in the housing element process regarding affirmatively furthering fair housing.
- ⇒ Amy H: Is this specifically aimed at the rise- newly renovated apartment complex? Formerly Vallco.
- ⇒ Neil P: No, the developer used a state law designed to help affordable housing to create the Rise. Checklist, bypass restrictions. The Rise is composed of around 20 stories, which bypasses local zoning restrictions of 4-5 stories. There is a surplus of parking in Cupertino, waste of land.

- ⇒ Luiza E: I second. No objections.
- ⇒ Neil P: Affordable housing must be scalable, build densely along transit use. Income diversification.
