- $\Rightarrow$  Adrian S raised the concern about the sustainability of Ecofund in the next 5 years.
- ⇒ Dennis S: They are still in an environmental state of coordinator and there is an ecofi code. Something exists if it is in the codes and bylaws not only because they have a line in the budget.
- ⇒ Amy H: I will work with the rest to make sure Ecofund is sustainable. It will be put into the bylaws, and appropriate committee code and all the job descriptions get updated to ensure that Ecofund is out in the open, and on the website.

- ⇒ Tj C: We are decreasing them (per year) and we don't want to cut it right away, as if they cannot afford the away games, they cannot represent the school.
- $\Rightarrow$  Zain M suggested allocating the amount of money to other areas that support the and are directly in contact with the student body.
- $\Rightarrow$  Tj C: They are still part of our committee, our student body, and we cannot say that there is no benefit to us.
