## Shared Governance Reports

- Adrian S: Arts on campus met on February 27. One of our main goals is to make classrooms less sterile by inviting classroom participants to take part in art in their classrooms. The challenges include the expensive process of testing for asbestos and ensuring that any art is fire safe. Any time the wall is pierced to hang things, the college is required to complete this lengthy and expensive process. Furthermore, paper decorations like those used at the village's opening are not fire safe. To combat this, I recommended that we consider painting directly on the walls like murals. The other main project Arts on Campus is working on is installing rabbit sculptures painted by De Anza students. Look out for these as they will be installed near April.
