Test & Quiz scores must average 75% in order to pass course. Therefore, a total of 98 points must be earned on the 2 tests and 4 quizzes in order to pass this course. The case studies (20 points) is <u>not</u> included in this 75% rule. If Test I score <75%: student is <u>required</u> to make an appointment with instructor within 7 days. Possible extra credit of 3 points (not included in the 75% rule) may be offered, but cannot be used to pass the class.

## Attendance (via Zoom)

Attendance is strongly recommended. If a student must be absent from a lecture, **it is common courtesy to inform the instructor before the class.** There are no make-up quizzes. Students are responsible for all information and announcements that are presented during lecture, even if they are absent that day.
