Student Learning Outcome Statements (SLO)

By the end of this class, you will be able to:

• Demonstrate a knowledge of basic legal terminology and basic tort, constitutional, criminal, administrative and contract law.

• Identify ethical issues in a business law context and evaluate factually simple contract issues using basic common law or UCC rules.

Required Materials:

- Required textbook: Essentials of Business Law Custom, 1st Edition 2019 (ISBN 978-0-357-43496-3). This is a physical (paper and ink) textbook and can only be purchased from the De Anza College online bookstore because we're the only school that uses it.
- Alternative textbook: <u>Essentials of Business Law eTextbook</u>, <u>6th Edition</u>, Jeffrey F. Beatty, Susan S. Samuelson, and Patricia Sanchez Abril, Cengage, **2019** (ASIN: B078KJR66M).
- Second alternative textbook: <u>Essentials of Business Law</u>, <u>6th Edition</u>, Jeffrey F. Beatty, Susan S. Samuelson, and Patricia Sanchez Abril, Cengage, **2019** (ISBN 978-1-337-40419-8). This is a physical (paper and ink) textbook that is widely available from many sellers.
- <u>Important</u>: Please arrange to have a book in your possession by Monday, January 3. Note that earlier editions of the textbook will not work. Only the 6th edition will work. Even the first textbook listed above is based on the 6th edition of the original textbook. It is called the 1st edition because it is a custom textbook used only here at De Anza College, but it is based on the 6th edition of the original textbook.

Course Requirements:

<u>Orientation videos</u>: This class is offered only through **Canvas**. Canvas can be accessed from the Student tab in MyPortal, or by going to <u>https://deanza.instructure.com</u> and using your MyPortal credentials to log in. You will find a collection of orientation videos inside the course website in Canvas, near the top of the page, grouped under the heading "Course Syllabus and Orientation Videos." It is really important that you watch these videos. They will explain how you earn points in the class, and how and why to make a solid and timely start in the class.

Attendance: Although this is a 100% online course, it still has an attendance requirement. The attendance requirement for this class has two components: 1. Any student who earns fewer than 1 point during the first week of the quarter will be dropped from the class as a no show, and 2. Each student must hit certain cumulative online point thresholds, one on each of the first seven Sundays of the quarter.

Here are the minimum point thresholds each student **must** meet to avoid being dropped for inadequate attendance, per component two of the attendance requirement in this class:

Online quizzes: The online quizzes are due weekly, always at 11:55PM on a Sunday, and are required. You will find them in De Anza's **Canvas** system. There is no cost to access the Canvas system, but you must be currently registered in the course on MyPortal in order to have access. Once during the quarter – **on Sunday**, **Mar. 13** - you will face two chapters'-worth of online quizzes due on the same night. See the Important Dates section at the end of this course syllabus or our course website in Canvas for details regarding when each chapter's quizzes are due. The online quizzes are open book, open note, but they are not to be taken collaboratively. Each student must complete their own online quizzes without assistance from others. Online quizzes can be completed up to one week late, but your grade on late quizzes will suffer a penalty of 4% per full-or-partial-day they are late.

Examinations: There will be two exams: one midterm and one final exam. Both exams are **online** and **asynchronous** and consist of **four parts each**. Each part of each exam is **required**. The final exam is not comprehensive (it's essentially a second midterm that you take during final exams week). Late midterms and finals will, like the online quizzes, suffer a lateness penalty of 4% per full-or-partial day. However, midterm parts may be no more than seven **days** late and final exam parts may be no more than seven **hours** late.

General Information:

• <u>Last date to drop with a W</u>: If you are not doing well in the course, or are unable to finish out the course, you may drop yourself from the course provide you do so by <u>*Friday, Feb. 25, 2022*</u>. Late drops (defined as any drop requested or attempted after Feb. 25, 2022) are not permitted.

A Word About How I Round Grade Percentages:

I do not round all grades upward as some instructors do. I will round a grade of 91.5% up to 92%, so that would earn a letter grade of A, but I will always round a grade of 91.4999% grade down to 91%, so that would earn an A-. I use the same rule for all the other breakpoints listed in the above schedule.

A Word About the Difficulty Level of This Course:

This course is one of only three De Anza College Business courses that is not only CSU-transferable but also U.C.-transferable. This means if you earn a passing grade in this course here, then transfer to any college in California's U.C. or CSU systems, such as U.C. Berkeley or San Jose State University, you will be treated has having passed Business Law I there for the purposes of earning any degree they offer that requires that course. They will not make you take their version. Passing it here counts the same as having passed it there. In order to maintain this transferability, we must periodically satisfy schools like U.C. Berkeley that this course is as difficult and thorough as the course they offer under the same name. For that reason, you may find that this course is a bit more difficult than some of the other courses we offer here in the De Anza College Business department.

Grade Reporting:

All grade reporting will be done inside Canvas. See the orientation video "How to Check Your Grade So Far" on the course website in Canvas for details.

Academic Integrity Policy:
