At the January 8 FODARA Board meeting, most officers volunteered to serve one more year in their current position: Mike Paccioretti will continue as President, Bill Lewis as Vice President, Ed Burling as Treasurer, Cindy Castillo as Communications Coordinator, Tom Roza as Secretary, Tom Strand and Faith Milonas as Joint Labor Management Benefits Committee (JLMBC) representatives. Of the four current Members At-Large, Janice Carr, Cindy Castillo, and Claudette Penner will continue, but since Bob Hubbs has decided to "retire" at the end of May, FODARA is seeking several additional Board members—the more the better!

FODARA supports <u>you</u> by providing representation (a voice) at JLMBC and a Retiree Gold Card, which entitles you to an FHDA parking permit, a library card, free or reduced admission at some events, and more. In addition, FODARA



offers several ways for retirees to stay informed and communicate with others: *After-Words* (this newsletter); five social events each year; a website; the email listserv; and a Facebook page.

<u>You</u> can "pay it forward"—support FODARA—by joining the Board (email Mike Paccioretti to volunteer), serving on a subcommittee, planning/hosting a social event, attending the yearly get-togethers, or donating to the Student Scholarship Fund.

## STUDENT SCHOLARSHIP Q&A



The four FODARA scholarships, totaling \$4,000 with two \$1,000 awards at each campus, will soon be awarded: 43 Foothill students and 60 De Anza students applied. Examples of the winners' applications will be in the May or September issue of *After-Words*. Thank you to Robin Latta, Assistant Director Foothill-De Anza Foundation, for providing the following information.

**Q:** How many scholarships are available each year and what is the range of awards? A: The Foundation gives out more than 500 scholarships annually totaling about \$500,000; more are available from outside groups. The awards range from \$500 to \$7,000 with the typical amount between \$500 and \$1,000.

## Q: What criteria is required to apply for a scholarship?

A: The standard is a minimum 2.5 GPA and enrollment in 6 units; depending on the donor, those criteria can be added to or edited. Almost all students can find a scholarship for which they qualify.

#### Q: What are the main categories of scholarships?

A: There are five general groups: <u>Merit</u> (for students with 3.5+ GPA); <u>Transfer</u> (for those transferring in the fall to a 4-year institution); <u>Area of Study</u> (for those in certain disciplines, e.g., Business & Computer Science, PSME, Creative/Fine Arts, Workforce, Language Arts); <u>Community Service</u> (for those active in projects either on or off campus); and <u>Great Perseverance</u> (for those who have faced obstacles, e.g., financial, first in family to attend college, disability). Specific scholarships include, as examples, those only for Veterans, reentry students, healthcare students, or single parents.

#### Q: What is the usual timeline for the scholarships?

A: The process, now done entirely online via students' My Portal, typically starts in Fall Quarter with the application deadline in mid-February. Selection occurs March through April, and awards are distributed in May and June.

#### **Q**: Who is on the scholarship committees?

A: Most scholarships are first read online by a general committee, one at Foothill and one at De Anza, comprised of staff, faculty, and students. In February, the campus Financial Aid Officer sends out a request for readers, some of whom can be from the community at large\*. The general committee selects the top candidates for each scholarship, and their applications are then forwarded to the Finalist Committee, which is comprised of the Financial Aid Director, a faculty member, and the Foundation Assistant Director (Latta). As they read the finalist applications, they are mindful of choosing a varied selection of students so that as many qualified students as possible receive scholarships.

\* Starting with the 2020 awards, FODARA members will be invited to serve on a general scholarship committee—when the request for volunteers is issued in February, it will be forwarded to FODARA to post on the listserv as a volunteer opportunity.

#### Q: What criteria are used to choose scholarship winners, including for FODARA's?

A: The Finalist Committee tries to match the best student within the spirit of each scholarship. They review any required criteria (GPA, units, community service, area of study), but the biggest factor is a student's My Story essay, since through it the committee learns about the student's personal history, obstacles, and dreams for the future, all of which helps most to inform the decision.

FODARA's scholarship criteria are threefold: students must have completed at least two quarters at the college, maintain a 3.5 or higher GPA, and have financial need. Involvement in campus activity or community service is considered a plus.

## HEALTH CARE BENEFITS UPDATES: 5 ITEMS

Below is a summary of the Joint Labor Management Benefit Committee (JLMBC) meeting on February 21, 2019. The next JLMBC meeting is scheduled for May 23, after the May issue of *After-Words* will be published; if any information presented is time-sensitive or relevant to retirees, FODARA will send an email alert with the details.

## 1. Plan Year 2019 Migration Report

Lockton handed out a spreadsheet showing the migration of FHDA Active Employees/Non-Medicare Retirees and Retirees with Medicare from Plan Year 2018 to Plan Year 2019.

The number of Actives/Non-Medicare Retiree participants dropped from 1,116 to 1,038 (-7%). The District could not explain this drop to JLMBC members as only six additional participants had waived coverage from the previous year. Lockton was asked to try to figure out the discrepancy and report back. Other changes are as follows:

## For Actives/Non-Medicare Retirees:

- The overall cost of premium contributions went down from \$3,166,080 to \$2, 935,416 (-7%);
- The overall District cost went down from \$15,711,061 to \$14,816,186 (-6%);
- The PERS Choice numbers dropped from 407 participants to 371 (-9%);
- The Kaiser Plan numbers dropped from 588 participants to 559 (-5%);
- The Anthem HMO Traditional Plan number increased from 18 to 24 (+33%).

## For Retirees with Medicare:

- The overall number of participants increased from 699 to 708 (+1%);
- The overall cost of premium contributions went down from \$1,528,812 to \$1, 523,484 (-.3%);
- The overall District cost went up from \$5,126,249 to \$5,166,813 (+.8%);
- The biggest drop in participation rates occurred in the PERS Select Plan, dropping from 259 to 237 (-8%);
- The largest increase in participant numbers was in the new UHC Medicare

Advantage Plan, increasing from 20 to 45 (+125%). Both the District and Lockton promoted this plan primarily because of cost savings to both the participant and the District.

## 2. New ACH Administrator

The District announced it has hired Discovery Benefits as the new Third Party Administrator for the Health Reimbursement Account to replace SECOVA; the Benefits Units was not getting the assistance it required from SECOVA, which had outsourced its support function to India.

As of June 1, 2019, Discovery Benefits will be responsible for the direct deposits of the monthly CalPERS premium variance reimbursement (employer contribution) and as of July 15 the quarterly Medicare Part B reimbursement; if/when applicable, it will withdraw funds from bank accounts for any overpayment or necessary adjustment.

A new Automated Clearing House (ACH) form for Discovery Benefits is included in the annual Retiree Survey packet, which was mailed the week of February 25. This form, along with the Survey, must be filled out and returned to the District with a voided check attached by March 31, 2019.

## 3. Plan Year 2018 Rate Stabilization Fund (RSF) End of Year Report

Lockton handed out another spreadsheet showing the drawdown in the RSF from 2016-2018 and comparing their projected costs to the actual costs of all aspects of the Health Benefits Plan. For the Dental and Vision plans, Lockton has been

able to more closely align the actual costs to the projected costs by analyzing the data carefully. The RSF balance is a healthy \$8,320,914, down from \$9,933,230 in 2016 (-16%).

## 4. Student Loan Refinancing Programs for Employees

Lockton distributed a handout that listed various ways the District could help finance student loan debt for its employees. Two examples refinancing were inviting companies campus provide on to information on how to lower interest rates and the District contributing a fixed monthly dollar amount into an account designated for student loan pay down. Lockton reported some Bay Area private sector employers looking into these and other are options. JLMBC decided this matter was a negotiation item so should be deferred to that arena.

#### 5. CalPERS Update

Although the January issue of *After-Words* reported that a change to CalPERS regions used to determine plan rates was <u>not</u> imminent, the boundaries for HMOs

regions were recently modified. At its December meeting, CalPERS voted to reduce the HMO regions from five to three in order to have a larger number of members in each region—these larger groups will allow CalPERS to compete better in the market place. The Bay Area HMO Region will be included in the new, larger Northern California region. <u>NOTE</u>: for CalPERS PPO plans (Care, Choice, and Select), the regions have not been changed, i.e., remain at five.

For plan year 2020, this adjustment of CalPERS regions will likely cause some HMO premiums to increase, but, at this time, CalPERS estimates twice as many members will see a decrease in rates as will see an increase. Their projections include some members in the most northern part of the new Northern California region, in particular in the Sacramento area, having the highest rate increases.
