FODARA. Your \$10 membership dues and a scholar-ship donation are appreciated but voluntary.


ANNUAL JUNE PICNIC LOTS OF FUN FOR ALL!

FODARA'S DEMISE— CONSEQUENCES FOR ALL

FODARA's continued existence is in serious jeopardy because our current executive officers are chronically tired of re-upping for the umpteenth time because no new candidates step forward from our ranks to serve. Consider: The overriding issue that binds retirees to the FHDA District is health benefits. FODARA certainly has other important functions like communications via the AfterWords Newsletter and Directory, scheduled social functions and scholarships, but the existence of an organization that can speak for retiree interests earns FODARA a seat (albeit a non-voting one) at the Joint Labor-Management Benefits Council which formulates and recommends benefit changes to the FHDA Board. Without FODARA, we have no formal representation at that Council.

For whatever reasons during my tenure as your representative over the last 18 months, the District and the unions have listen carefully and responded very well to retiree interests presented at the Council (in part, I suspect, because all of them know they'll eventually become FODARA members). And notwithstanding the grumbling I've heard about the Benefits Unit, I personally think they're doing a terrific job for retirees, especially being as understaffed as they are. We have just undergone a sea change in health benefits to contain costs, and we retirees have required a disproportionate amount of effort to track, inform, counsel and help because we're a scattered, hard-of-hearing and sometimes obstreperous group often with complex problems.

So, my plea to you local retirees is: throw your hat in the ring for some office in the next FODARA election. The workload is modest, the meetings are infrequent and casual, and in my opinion, we absolutely need a credible FHDA retirees' organization to earn a seat at the Council.

The 408 Area Code

After October 20, 2012, all calls made <u>inside the</u> 408 area code, will require dialing 1 plus the 408 area code. A new 669 area code will be layered upon the 408 area code region. So, after October 20, all 408 calls placed without dialing "1408" before the seven digit telephone number, will result in a recording. It will advise the caller to dial one plus the area code and the telephone number to complete a call.

BENEFITS UPDATE

A new Open Enrollment period is upon us. The September 10-October 5 enrollment is for calendar (and plan) year 2103. Here are some recent benefits highlights.

If you like your current plan <u>and</u> your dependent situation is unchanged, you can do nothing; that rolls over your entire current election to the 2013 plan year.

If you just retired, want to change your current election, have a new dependent situation, or change your Electronic Fund Transfer (EFT) account, then you must submit the proper paperwork during this election. Even though the CalPERS mailing materials say to send your paperwork directly to CalPERS, don't do it. Instead, send all your paper work to SECOVA in Newport Beach, CA. They've been hired to check all paperwork for accuracy and completeness, to notify you of any problems and to submit your completed paperwork to CalPERS.

Since many retirees will roll over their current election and the District is working out kinks in reimbursements to EFT accounts, this enrollment should be far easier than the last.

The PERS Select-Medicare plan is now available in <u>all</u> California counties but not out-of-state. Since this makes little sense the District is urging CalPERS to offer this plan to both out-of-state and California Medicare eligible retirees.

Reminder 1: If you (and your spouse, if any) are Medicare eligible and you live in California, choosing between PERS 'Select' and 'Choice' is easy; coverage for both plans is <u>identical</u>, but PERS Select is cheaper, so choose PERS Select.

Reminder 2: The PERS Care, Choice and Select network restrictions do not apply to retirees on Medicare. Their network is all Medicare providers, both in- and out-of-state, with Medicare as the primary insurer and Blue Cross as secondary. But be careful: if you use a non-Medicare provider, you may have to pay the entire tab.

Reminder 3: For retirees, paying your monthly healthcare Required Contribution (the subsidized rate agreed to in collective bargaining) is a two-step process. First, a CalPERS Premium will be deducted (the rate that most

CalPERS members pay state-wide) from your retirement check. Then, near first of the month, the District deposits the difference between the *CalPERS Premium* and the *Required Contribution* into your EFT account (all retirees must have one). Sorry, there's currently no way around this.

A Warning – Kaiser Contributions Going Up: The Joint Labor-Management Benefits Council recommended that the District subsidize PERS Select the most, to make it the most affordable plan, within reach of all District employees, with all other plans being buy-ups. Before the move to CalPERS, the District subsidized Kaiser coverage to make it the most affordable plan, so many employees and retirees joined Kaiser. Recently Kaiser CalPERS Premiums have risen sharply. To protect the shrinking benefits stabilization fund and to give employees and retirees time to transition from the previous to present most affordable plan, the Council recommended that the Kaiser *Required Contribution* be heavily subsidized this year but then rise substantially in 2014 and 2015 to reflect real costs, although the final rates have not yet been negotiated.
