#### **District Benefits Report – Lisa Markus**

#### **JLMBC highlights for meeting on Wednesday April 9, 2025:**

- **Medicare Part B and IRMAA (Income-Related Monthly Adjustment Amount):**
  - Retirees in Medicare pay basic amount of Medicare Part B of \$185 per month
  - If income is over \$106,000 (single) or \$212,000 (joint), will also pay the IRMAA amount, which starts at \$74 per month
  - Currently, for Pre-97 retirees in Medicare, the District is reimbursing both the basic amount and the IRMAA
  - However, the language in the classified contracts (Association of Classified Employees, California School Employees Association, Police Officers Association, Teamsters) only requires the District to pay the basic amount
  - Starting in July 2025, for classified retirees, the District plans to only reimburse the basic amount. Retirees from the Faculty Association, Administrative Management Association, and Confidentials will not be affected at this time.
- **Dependent Eligibility Verification:**
  - Notification letters will be sent on April 16; Secova will manage the process
  - Verification packets will be sent in May with deadline of June 6 to respond
  - Be sure to upload correct documentation to keep your dependents on your insurance plan; Non-verified dependents will be removed from the plan effective July 1, 2025.
