COOL committee – Seven (7) volunteers

1) James Adams, FT, non- Tenured

Library

I have several years of community college experience split between West Valley College and De Anza College. I'm a recent MLIS graduate who took courses through a fully online graduate program (this was right before COVID-19). The last couple years have shown the shift from in-person teaching modalities to online and hybrid modalities was difficult in a multitude of aspects.

I want to be able to advise and shape changes in these modalities, especially as a representative of the college's library, wherein I have a different perspective in comparison to instructional faculty in other divisions.

2) Danielle Altman, FT, Tenured

PE/Athletics

Prior to the pandemic, I was one of the first faculty in Physical Education to teach online classes in our field. I began with a lecture course, and expanded into physical activity courses. My physical activity courses are some of the most popular classes in our department. They include Yoga and Pilates. I continue to expand my knowledge of Canvas, and am able to use online resources for both lecture and activity courses in my area. I have increased my knowledge and skills for teaching online during my sabbatical - with coursework specific to improving effectiveness in teaching online.

Learning effectively online is different for every student. Being open for communication, responding timely, and using motivational techniques helps a diverse population of students be successful in an online class environment. I believe that all students should feel safe, included, and that their instructor is open and available. I am always offering in person and online office hours. I also encourage and "nudge" students to participate - and create as flexible an environment in my online class as possible for every student to succeed.

3) Tracy DeHaan, PT, with REP Social Sciences and Humanities, Sociology

1) I have been online teaching since 2016. I have received certificates in online teaching from multiple campuses while serving as an adjunct (West Valley College, Santa Clara University, San Jose State University, and Cañada College). I have gone through the POCR process and one of my classes is certified at West Valley College. I will soon have a second course certified at Cañada College. I am also a certified peer-reviewer (@One) for POCR. I have served on the West Valley College DE Committee for two academic years as an adjunct representative. I believe these experiences have provided me with important insights into distance education, as well as the processes of a distance education committee.

2) In working as a POCR reviewer, I've learned that online education varies greatly across disciplines. So, while our standards should be the same, how those standards are applied will vary greatly. Representation of various disciplines will be important to offer the greatest insights on how to effectively implement policy changes and support programs for our faculty. I also believe that each of us has a unique standpoint within the institution, as well as within the greater society. It's important to have diverse perspectives, especially if we have a goal of making online education accessible and inclusive to our diverse student body. Diverse voices are necessary sthat we can learn from each other and gain a better understanding of how to be effective leaders in online education. Diverse working groups have also been shown to be more effective at problem-solving and

stronger at innovating new ideas.

4) Emily Garbe, FT, Tenured

My doctoral research focused on the effectiveness of online communities in providing a sense of belonging. I strongly believe that an online environment is not only an effective vehicle for learning but also for social support. I have been using an online learning system (Moodle) long before Canvas was adopted by De Anza.

I also have a master's degree in computer science and believe that we should continuously leverage new systems, tools, and platforms to enhance student engagement and online engagement. I was a speaker at the CCC Online Teaching Conference in June 2023 on the effectiveness of interactive video quizzes (using PlayPosit and Studio) embedded in lecture videos for asynchronous classes.
