2 years ago, we amended board policy to include specific language about Adult School students being eligible for dual enrollment and have actively been trying to expand our dual enrollment opportunities.

Creating specific Bridge workshops for the many diverse programs that the Adult Schools have to offer would help with a warm handoff from the Adult Schools to the Community College. These programs include English as a Second Language, Career Technical Education, Adult Secondary Programs (High School Equivalency and High School Diploma), Adults with Disabilities, Parent Education, and other CAEP funded programs.

Our project objective is closely aligned with several Equity Core Values. By creating bridge workshops we are embracing the institutional responsibility to be student-ready and assist students in obtaining necessary resources. We are also focused on acknowledging and advocating for the multiple access points and varying education goals that exist for students.
