Subject: Accreditation Timeline and Proposed Standards Teams

A charge of the College Planning Committee (CPC) is to support and guide the college through the ACCJC accreditation process. In preparation for our site visit in fall 2017, between winter 2016 and spring 2017, the college will be writing a self-study report for the Commission and site visit team to address all accreditation Standards and federal Educational Requirements (ERs).

1. The CPC would like to propose that for the remainder of 2015-16 and the full 2016-17 academic year, it becomes the temporary Accreditation Steering Committee, along with additional members from the self-study teams who wish to join the committee. The Steering Committee will be responsible for: monitoring progress on the self-study report, drafting the quality focus essay, compiling the self-study reports into one document, soliciting feedback from the campus community, and incorporating the feedback into the final draft.

2. The CPC would like to additionally propose that the current shared governance groups serve as the self-study teams for their respective areas for the duration of the accreditation self-study process. Each shared governance group will be responsible for drafting a response to a particular area within the Standards that is most relevant to their work. The following self-study teams and their proposed Standards are:
